| April 4, 2017 | City Council authorized an agreement with HdL to assist in the development of an ordinance, permit system cost recovery program and tax measure. |
| April 18, 2017 | City Council authorized a cost reimbursement agreement with Nc3 (Caliva). (agreement signed and \$50,000 deposit received) |

One additional party has requested to enter into a cost reimbursement agreement, Genezen, formerly Hanford Gardens. The City has also received notice that Purple Heart is considering a Hanford location again.
