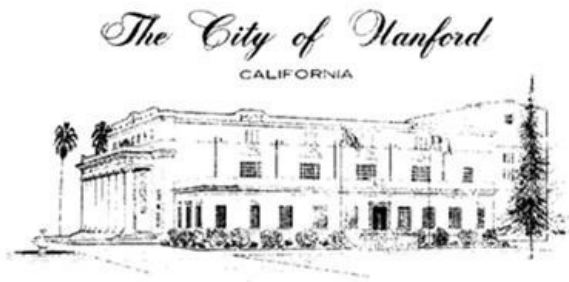

FORD STREET NO PARKING

RECOMMENDATION:

That the Parking & Traffic Commission make a recommendation to the City Council to authorize the installation of No Parking Anytime signs along the south side of Ford Street between Park Avenue and Kaweah Street and to change Section 10.16.130 of the Hanford Municipal Code to include the south side of Ford Street as a No Parking zone.

DISCUSSION:

Staff received a request to investigate parking & traffic issues on Ford Street due to opening of the Kings Gun Center. Staff investigated and found that Ford Street is not wide enough to allow two lanes of traffic to flow safely with vehicle parking on both sides of the street.

Ford Street is an east-west bound street with a curb to curb width of 30' and approximately 633' in length. The speed limit is prima facie 25 MPH. There is residential on the north side of the street and sidewalk and fencing along the south side. To allow for safe flow of traffic on Ford Street staff recommends restricting parking on the south side of Ford Street and only allow parking on the north side which will allow for 2 - 10' travel lanes. See attached photo and drawing.

With the Parking & Traffic Commissions recommendation, staff would take the item to City Council to modify the Hanford Municipal Code to include the south side of Ford Street to be No Parking Anytime. Upon approval after the second reading, a 30 day waiting period would pass before the no parking signs and pavement markings be installed.

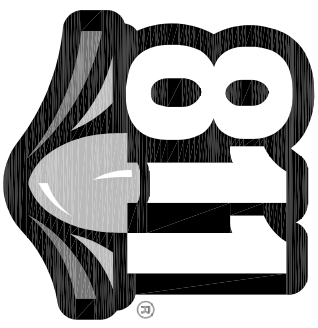
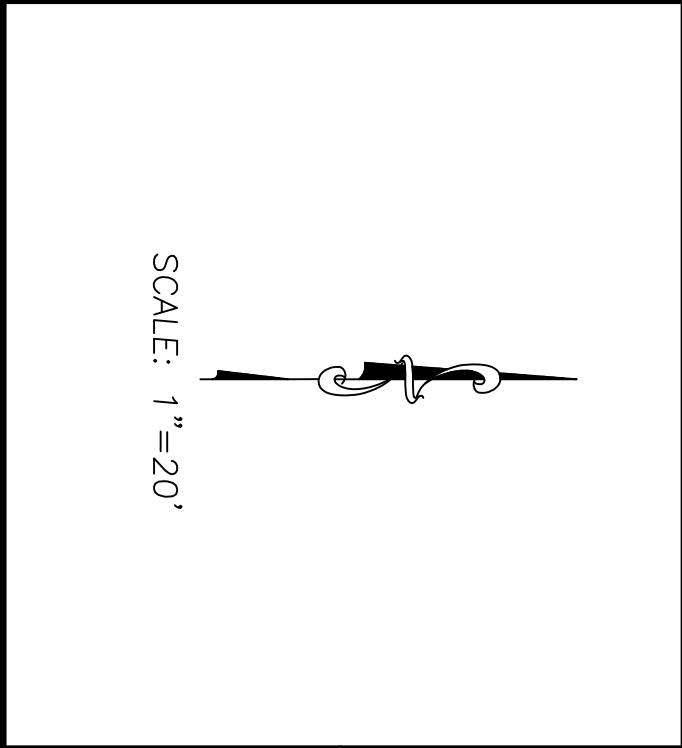

REQUEST FOR MULTI-WAY STOP AT SIXTH STREET AND IRWIN STREET

RECOMMENDATION:

That the intersection of Sixth Street and Irwin Street remain as currently signed.

BACKGROUND:

Staff received a request from a citizen to place stop signs on Sixth Street at Irwin Street to make the intersection a multi-way stop. It was stated that speeds are too fast and it was difficult to see traffic. To address this concern staff conducted a traffic study at this intersection.

Irwin Street is a northbound-southbound street that tee's on the north side of Sixth Street. Irwin Street has width of 56' and has curb and gutter both sides. This width is adequate for a single lane in each direction with room to park. Irwin Street is prima facie 25 MPH. Sixth Street is an eastbound-westbound street with curb and gutter both sides and a width of 52' with single lane in each direction with room to park. The speed limit on is posted 35 MPH.

The entering volume summary shows the majority of traffic is on Sixth Street with 2,621 eastbound and 2,102 westbound and Irwin Street is 997. The 85th percentile speed on Irwin Street is 17 MPH. The 85th percentile on Sixth Street is 25 MPH eastbound and 23 MPH westbound. There have been no reported accidents at this intersection in the last five years.

The warrant for multi-way stop was checked. The intersection does not meet the traffic warrant for multi-way stop at this time.

Staff recommends that the intersection remain as currently signed.

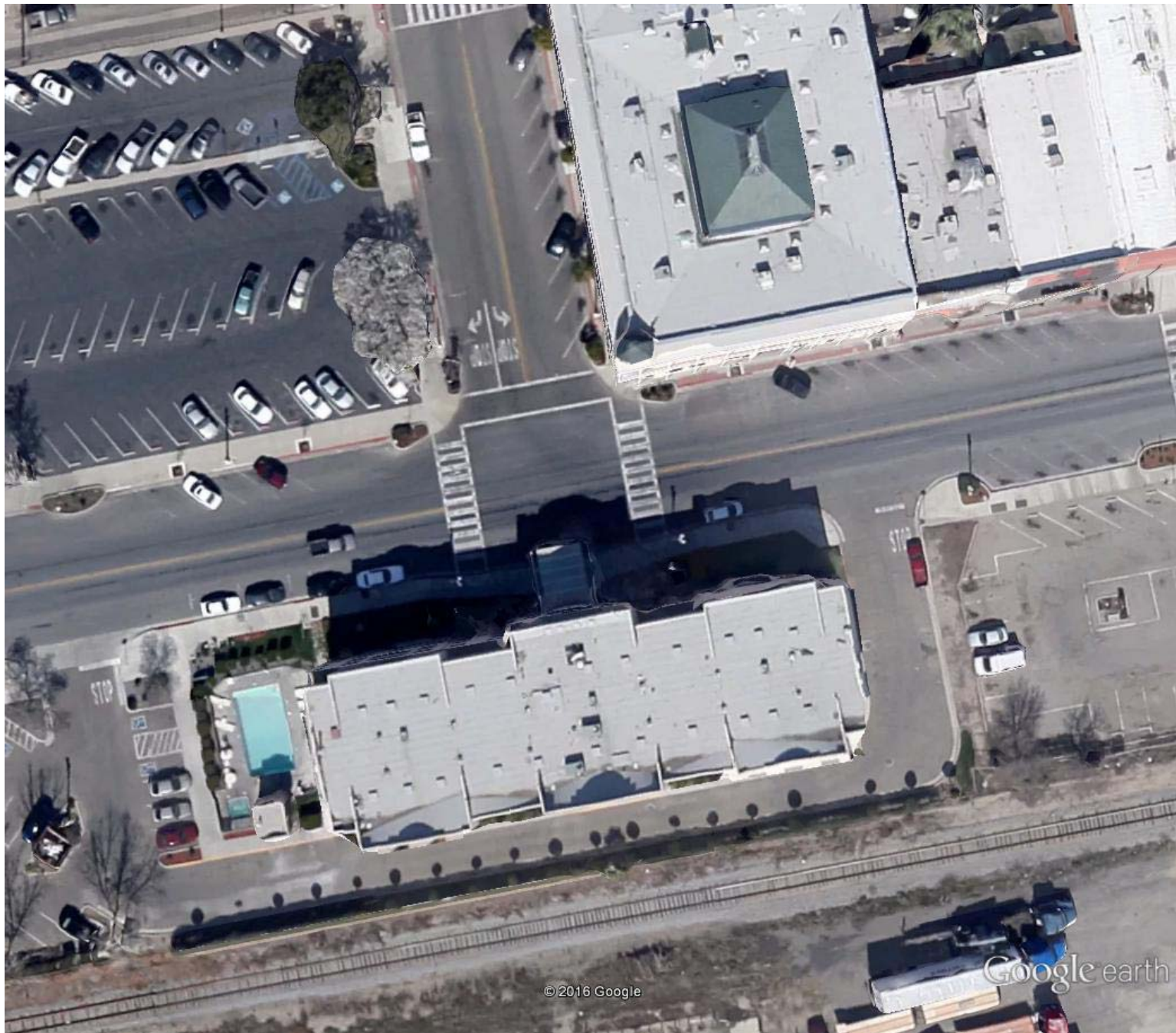

REQUEST FOR MULTI-WAY STOP AT MALONE STREET AND MIDDLETON STREET

RECOMMENDATION:

That the intersection of Malone Street and Middleton Street remain as signed.

BACKGROUND:

Staff received a request from Hanford School District to place stop signs on Malone Street at Middleton Street to make the intersection a multi-way stop. It was stated that speeds are too fast on Malone Street and traffic backs up during drop-off and pick-up. To address this concern staff conducted a traffic study at this intersection.

Malone Street is an eastbound-westbound residential street and Middleton Street is a northbound-southbound residential street. Both streets have with curb and gutter on both sides with a width of 38'. This width is adequate for a single lane in each direction with room to park. Both streets are residential prima facie 25 MPH.

The entering volume summary shows the majority of traffic is on Malone Street with 773 and Middleton Street is 595. The 85th percentile speed on Malone Street is 23 MPH eastbound and 29 MPH westbound. The 85th percentile on Middleton Street is 12 MPH northbound and 15 MPH southbound. There have been no reported accidents at this intersection in the last five years.

The warrant for multi-way stop was checked. The intersection does not meet the traffic warrant for multi-way stop at this time.

Staff recommends that the intersection remain as currently signed.
