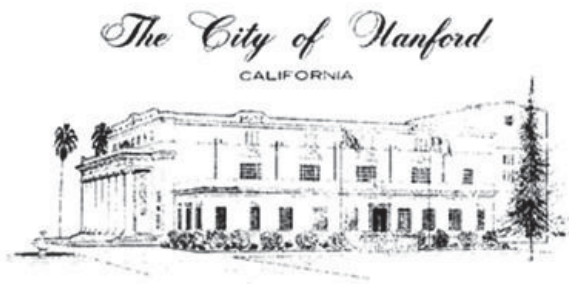

STAFF REPORTS

2. FORD STREET NO PARKING

Staff provided background information for the Commissions review and consideration.

Commissioner MacLELLAN stated that there would possibly be upset residents for taking parking away.

Staff informed Commissioners that there is alleyway access to the residences as well.

Commissioner SUDDS stated that there should always be a clear right-of-way for public safety.

Commissioner DWYER asked if this was brought to the Commission as a safety issue.

Staff informed Commissioners that it is a public safety issue and restricting parking along the south side of the street would allow for safe travel in both directions.

Staff informed Commissioners that this has been an ongoing problem that has multiplied due to the recent opening of the Kings Gun Center.

Commissioner BUTTS asked staff if the 12' wide lane could present a problem.

Staff stated they do not foresee an issue and that there are other 12' lanes in various location throughout the city.

Commissioner MacLELLAN asked what the fiscal impact would be for the project.

Staff stated the project would include 4 signs and minimal striping all done by city staff at a minimal fiscal impact.

STAFF COMMUNICATION

3. REQUEST FOR MULTI-WAY STOP AT SIXTH STREET AND IRWIN STREET

Staff informed Commissioners that the intersection did not meet warrants and will remain a 2-way stop. Commissioners asked if a "Cross Traffic Does Not Stop" sign could be placed on southbound Irwin Street stop sign. Staff stated that the streets department would place the sign.

4. REQUEST FOR MULTI-WAY STOP AT MALONE STREET AND MIDDLETON STREET

Staff informed Commissioners that the intersection did not meet warrants and will remain a 2-way stop. Commissioners asked staff to approach the School District regarding on-site pick-up and drop-off. Staff stated that they would contact the School District.

5. PED BIKE PLAN UPDATE

Staff commented briefly on the Pedestrian and Bike Master Plan. Staff informed Commissioners that the plan will go to the City Council meeting on February 16, 2016 for final approval.

6. CITY COUNCIL ACTIONS

Commissioner DWYER stated that some of the new street signs are flashing/not staying lit at night. Staff stated that the lights should be under warranty and will have the streets department look into it.

Commissioner SUDDS stated that she received a citizens complaint regarding a bright flashing light in the window of the Barber Shop on the west side of 10th Avenue just south the Green Valley Cafe. The citizen stated that this is a distraction for drivers in the area. Staff stated they will investigate.

Commissioner SUDDS stated that she received a second citizen complaint regarding the light at Centennial Drive at 12th Avenue. The timing of the light only allows 2 or 3 cars to turn on the light. Staff stated they will have the streets department investigate.

Commissioner MacLELLAN asked staff if the manhole covers along Fargo Avenue could be lifted. Staff stated that informed Commissioners that the item will be looked into.

Commissioner MacLELLAN asked staff if the light outside the civic center could be adjusted so it isn't shining in the face as you go down the stairs. Staff stated that they would ask the building department to look into it.

INTERSECTION STUDY - IVY STREET AND PARK AVENUE

RECOMMENDATION:

That the Parking & Traffic Commission do not make a recommendation to the City Council to make the intersection of Ivy Street and Park Avenue a Multi Way Stop.

BACKGROUND:

Staff received a request to place STOP signs on Ivy Street at the intersection with Park Avenue to create a four-way stop. It was stated that there have been several collisions at this intersection due to no stopping control on Ivy Street. To address this concern, staff conducted an intersection study of the location.

Ivy Street is an east-west bound street and Park Avenue is a north-south bound street. The intersection currently has a two-way stop with Park Avenue stopping and Ivy Street with the right of way through movement. There is a school in the vicinity of the intersection and visibility is clear from all directions.

Ivy Street and Park Avenue are two-lane residential streets with curb and gutter. The curb to curb widths on Ivy Street are 40' on the west side and 34' on the east side of Park Avenue. Park Avenue curb to curb width is 40'. These widths are adequate for a single lane in each direction with room for street parking. The speed limit on Ivy Street is 30 MPH and Park Avenue is prima

facie 25 MPH for a residential area. The 85th percentile speed on Ivy Street is 28 MPH westbound, 30 MPH eastbound and on Park Avenue it is 25 MPH southbound, 21 MPH northbound. The entering volume summary shows the majority of the traffic is on Ivy Street (2,814 vehicles per day on Ivy Street and 942 vehicles per day on Park Avenue). There have been five accidents reported at this intersection in the last five years.

The warrants for a yield sign, two-way stop sign, and multi-way stop sign were checked. Based on the multi-stop warrant, a four way stop was not warranted at this intersection at this time. Staff does not recommend that stop signs be placed on Ivy Street for east-west bound traffic to stop at the intersection of Park Avenue. Attached is an aerial photo of the area, warrants for yield, two-way stop signs, and multi-way stop signs, and entering volume and speed summaries.

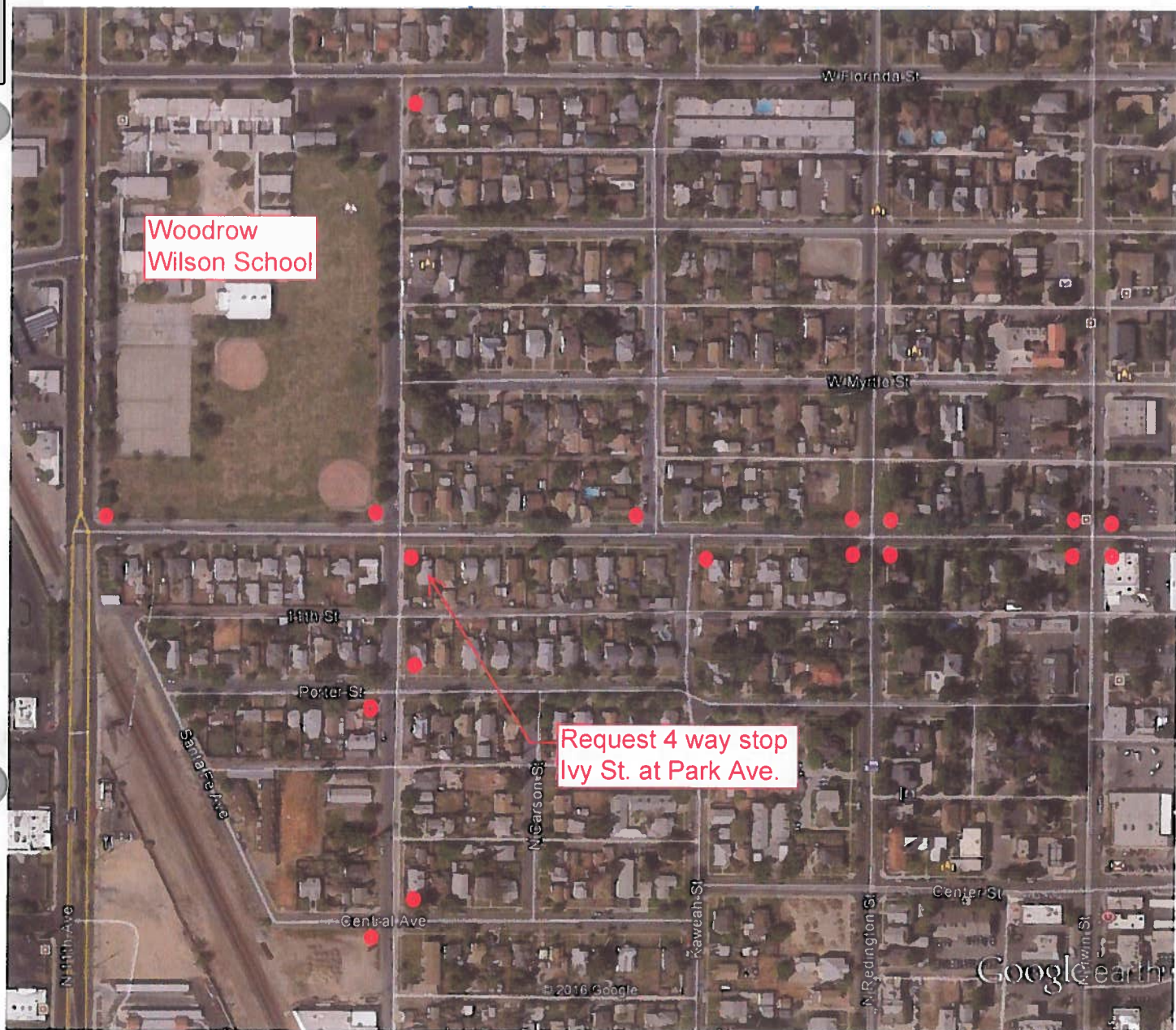

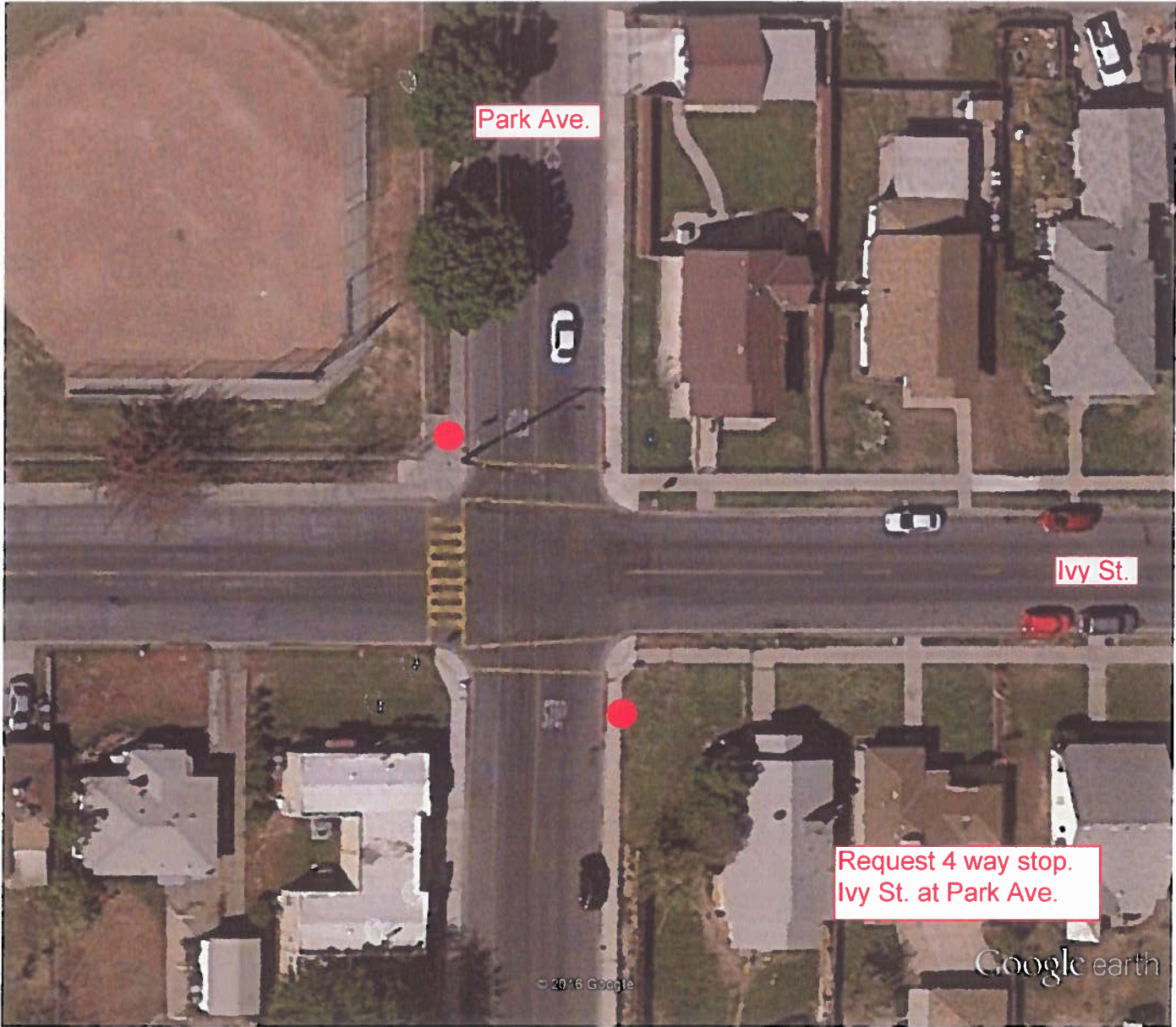

WARRANTS FOR MULTI-WAY STOP SIGNS

Multi-Way Stops may be considered at an intersection if any of the following conditions exist:

SATISFIED

1. TRAFFIC SIGNALS

Yes ☐ No ☒

Where traffic signals are warranted and the need is urgent, the four-way stop is an interim measure that can be installed quickly to control traffic while arrangements are being for the signal installation.

2. ACCIDENTS (3 total)

An accident problem, as indicated by five (5) or more reported accidents of a type susceptible to correction by a four-way stop sign installation in a 12-month period. Types of accidents susceptible to correction include right angle and left turn collisions.

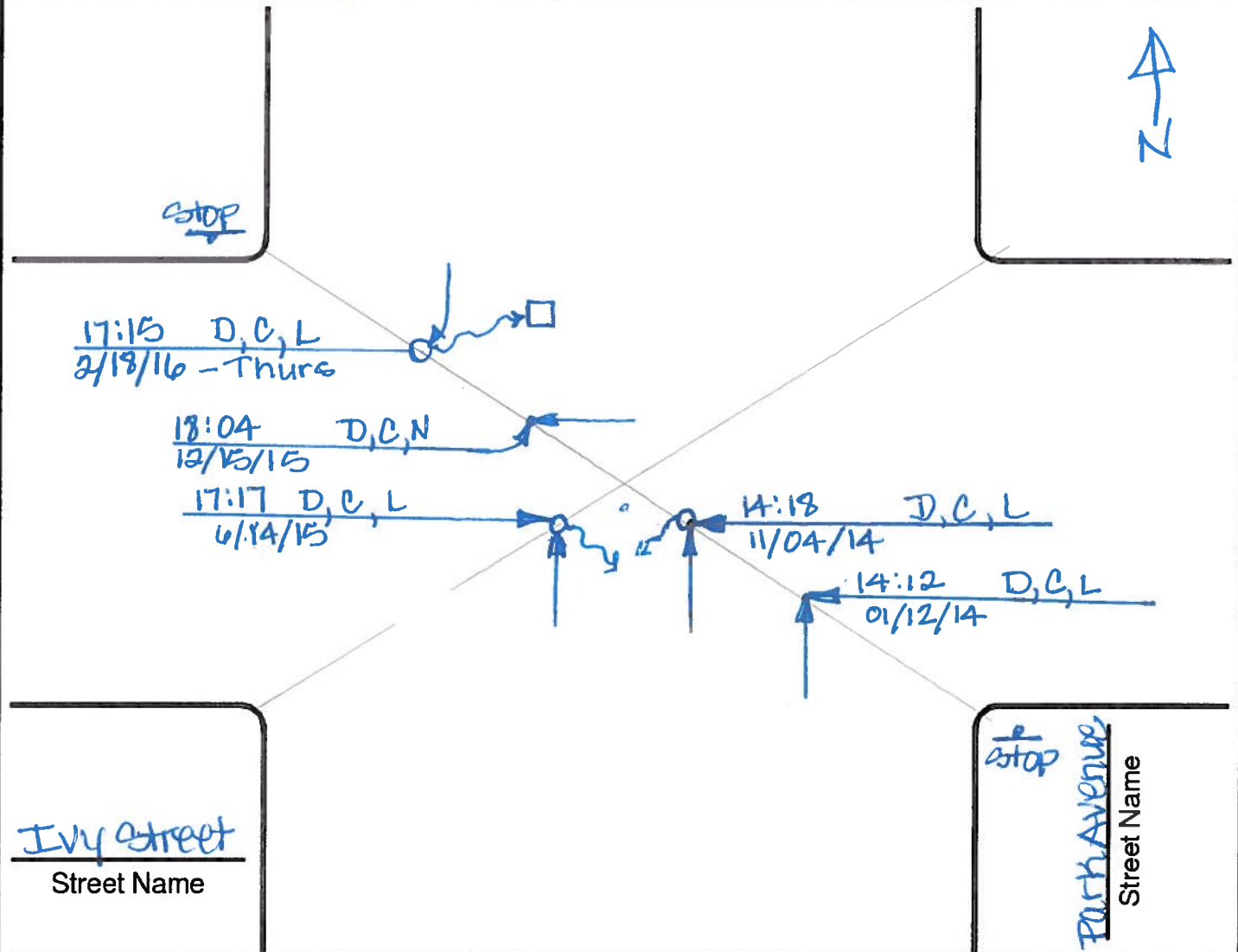

OPINIONS AND CONCLUSIONS:**COEFFICIENT OF FRICTION DOCUMENTATION:**

On 11-4-2014 at approximately 1500 hours, I conducted skid testing at the scene of the collision. The purpose of this testing was to determine a dry, ABS, coefficient of friction value between the tire/roadway. I operated the LIDAR unit to determine the test vehicles speed for each test. The vehicle used for this test was a Hanford Police Dodge Charger unit # 3 driven by Officer J. Adams. Officer Adams was given instruction on how fast to drive and how and when to apply the brakes. Upon completion of each test, Traffic Officer B McCreary measured the length of the longest skid mark with a roll a meter. The distance (d) and the LIDAR speed (s) for each test were combined in the following formula to determine a coefficient of friction.

Please refer to the attachment labeled "Skid Testing" for the formula.

SPEED ANALYSIS:

The braking distance of V-2 [REDACTED] was determined to be 43 feet based upon the physical evidence at the scene (Item # 1 Impending wheel skid). Using that distance and the previously calculated coefficient of friction of 1.152 (f) a speed in MPH (S) is determined using the following math formula:

The speed of V-2 at the start of the skid was at least 38.54 MPH. This is exclude of any speed loss that occurred as a result of the damage caused to V-2 or V-1 at the time of impact.

The braking distance (d) for a vehicle at a given speed can be determined using the vehicles speed in MPH (S) and the coefficient of friction (f) using the following formula: Please refer to the attachment "Braking distance" for the formula At 38.54 MPH, V- 2 was traveling 56.53 FPS (38.54*1.467). At 30 MPH a vehicle would be traveling 44.01 FPS. With the 43 foot skid mark left from V-2 and at 56.53 FPS I determined with 1.5 perception and reaction time that V-2 was at least 127 feet east of the impact on Ivy St. While on scene, Traffic Officer McCreary walked east on Ivy St and stood at the stop sign where V-1 was at when she came to a stop. As Traffic Officer McCreary walked east, until I could no longer see him due to blind spots by vehicles parked in the south side of the curb line of Ivy St, he was approximately 130 feet east of the impact on Ivy St. He continued walking east until I could see him again and he was now 356 feet east of the intersection. I was judging my view of other vehicles that were traveling west on the roadway was well. As V-2 was traveling west on Ivy St at approximately 38.54 MPH it took her 6.29 seconds to travel the distance of 356 feet. This is the distance that she traveled and was not visible to V-1. If V-2 would have been traveling 30 MPH (posted speed limit) it would have taken her 8.08 seconds to travel the distance of 356 feet. <u>SUMMARY:</u> As Party # 1 was driving north on Park St, she stopped at the stop sign at Ivy St. She then accelerated into the intersection in an attempt to continue north on Park St.

Before she could clear the intersection, she collided into Party # 2's vehicle that was traveling west on Ivy St. Ivy St does not have a stop sign for the westbound/eastbound travel. During my investigation of this collision I was able to determine the minimum speed that V-2 was traveling at the time the brakes were applied which was 38.54 MPH. The blind spots for V-1 were measured as well with the assistance of Traffic Officer McCreary. Based on the speed and FPS traveled of V-2, I determined that if V-2 had been traveling at a speed of 30 MPH (Which is the posted speed), V-1 would have had an additional 2 seconds at minimum to clear the intersection prior to impact. These vehicles that were causing a blind spot, were legally parked along the south curb line of Ivy St. Party # 1 sustained a complaint of pain to her left ankle area and was seen by paramedics while at the scene. Party # 1 chose to seek her own medical attention. Party # 2 was seen at the scene by Paramedics for a visible bruise and swelling to her left arm. She was transported to the Adventist Medical Center by Ambulance. Prior to V-2 being towed by Amigos Towing, I observed the front tires. Both of these tires had what is called "Speckling" on the rubber. The speckling is consistent with being caused by hard braking. (Photos of the entire scene were taken by Traffic Officer McCreary). <u>AREA OF IMPACT:</u> Measurements for the AOI were taken from the north west corner of the intersection. <u>CAUSE:</u> After investigation this collision, I determined that Party # 2 was the cause of this collision based on the minimum speed she was traveling at the time her brakes were applied. The posted speed limit for Ivy St is 30 MPH and the minimum speed I determined Party # 2 was traveling at the time her brakes were applied was 38.54 MPH. V-2 was only visible to V-1 for approximately 2.29 seconds at the time V- 1 accelerated from the stop. $(38.54 \times 1.467 = 56.53 \text{ FPS} \dots 130/56.53 = 2.29 \text{ seconds})$. This is excluding the speed she was traveling at the time of impact, and the distance her vehicle traveled after impact. Based on that information, I believe that V-2 was traveling faster than 38.54 MPH and was 10 or more miles per hour over the posted speed limit. She was found to be in violation of California Vehicle Code section 22350 which states: No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property. <u>RECOMMENDATIONS:</u> None

SUBJECT:

INTERSECTION STUDY - CERRITOS AVENUE AT HUMBOLT DRIVE

RECOMMENDATION:

That the Parking and Traffic Commission make a recommendation to the City Council to authorize the installation of stop signs on Humbolt Drive at Cerritos Avenue and to change Section 10.32.010 of the Hanford Municipal Code to include a two-way stop at this intersection.

BACKGROUND:

Staff received a complaint from a residence in the area of Cerritos Avenue and Humbolt Drive. The resident stated that drivers are traveling with excessive speed, are assuming the right-of-way and that there have been many near collisions. Staff conducted a study of the intersection.

Cerritos Avenue is a two-lane, north-south bound residential street with curb and gutter with a width of 38'. Humbolt Drive is a two-lane, east-west bound residential street with curb and gutter with a width of 36'. Both streets have room for parking on both sides and are residential prima facie 25 MPH. The intersection currently has no traffic control. There are no schools in the vicinity of the intersection. There have been no accidents reported.

The entering volume summary shows the majority of the traffic is on Cerritos Avenue with 661 vehicles per day and Humbolt Drive with 333 vehicles per day.

The warrants for a yield sign and two-way stop sign were checked. The intersection did meet warrants for a two-way stop intersection.

With the Commission's recommendation, staff would take the item to City Council to modify the Hanford Municipal Code to change the intersection to a two-way stop. Upon approval after the second reading, a 30 day waiting period would pass before the stop signs and pavement markings will be installed.

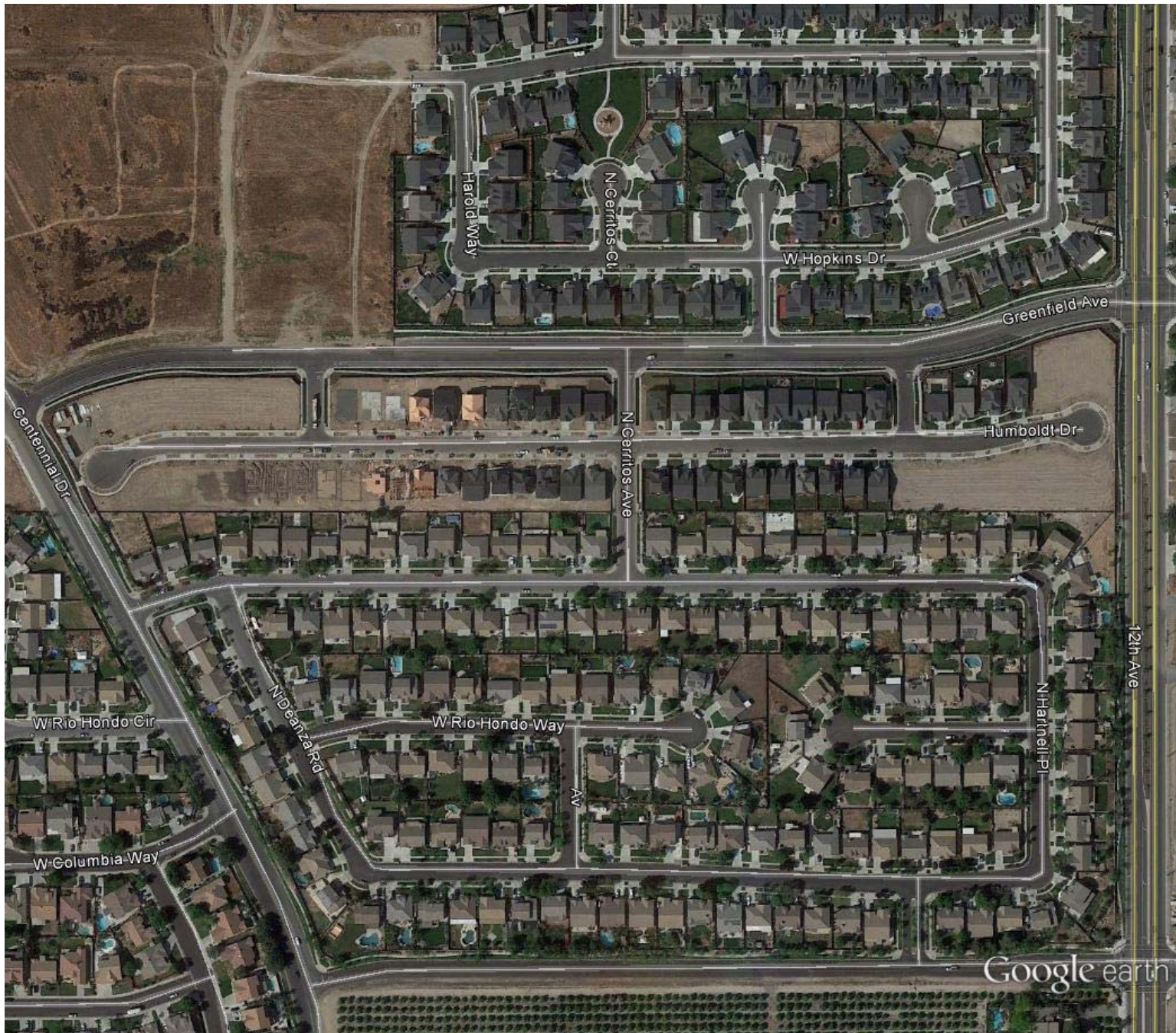
