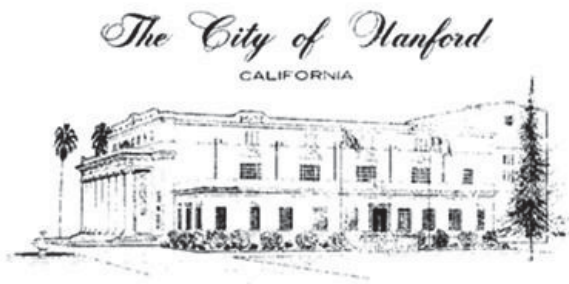

Staff presented a request by Hanford Elementary School District for a crosswalk on Florinda Street at Sequoia Circle. Staff conducted a traffic study at this intersection and determined that the intersection did not meet the warrants for a crosswalk. Gerry Mulligan, Director of Facilities & operations for Hanford Elementary School District and Joy Gable, Superintendent of Hanford Elementary School District both spoke in favor of the crosswalk. Staff responded to questions and comments from Commissioners. Commissioner DWIGGINS made a motion to table this item until better weather and another pedestrian study can be conducted and to have this item brought back to the Commission for future review.

Crosswalk on Florinda Street at Sequoia Circle: This item was tabled at the January 26, 2017 Meeting

RECOMMENDATION:

That a crosswalk not be placed on Florinda Street at Sequoia Circle.

BACKGROUND:

Parking & Traffic Commissioners tabled this item at the January 26, 2017 meeting asking that staff bring this item back to the Commission after another pedestrian count could be completed. Another morning and afternoon pedestrian count was conducted on Thursday, February 23, 2017. The re-count netted 40 pedestrians which is 9 more than the last count. Based on the re-count the crosswalk does not meet warrants.

Original Report:

Staff received a request from Hanford Elementary School District asking if a crosswalk could be placed on Florinda Street at Sequoia Circle. It was stated that students are crossing at this intersection. To address this concern, staff conducted an intersection study of the location.

Florinda Street is an east-west bound two-lane residential street with a curb to curb width of 60 feet. This width is adequate for a single lane in each direction with room for street parking with Florinda Street having the thru movement. Sequoia Circle is a north-south bound two-lane residential street with a curb to curb width of 38 feet. This width is adequate for two lanes in each direction with room for parking with Sequoia Circle having to stop.

The speed limit on Florinda Street is 30 MPH on Sequoia Circle it is prima facie 25 MPH. The 85th percentile speed on Florinda Street is 34 MPH with the majority of the traffic volume being on Florinda Street. In the last five years, there have been 1 accident reported at the intersection

which evolved a single vehicle hitting a fire hydrant. . The sight stopping distance at the intersection is adequate for north bound Sequoia Circle and westbound Florinda Street however, the sight stopping distance for east bound Florinda Street does not meet the required sight distance and would require additional traffic controls for the condition.

There are 2 schools in the vicinity of the intersection and crosswalks are located approximately 500 feet east and 500' west of the intersection. The crossing to the west is a controlled crossing location. Students from Lee Richmond Elementary School and John F. Kennedy Junior High School are provided a Suggested Routes to School map at the beginning of the school year which directs them to the crosswalks previously mentioned

The warrant for a crosswalk was checked, and the intersection does not meet the four basic warrants based on the low pedestrian counts, sight visibility for east bound traffic, existing crosswalks in close proximity, and adequate gaps provided.

A gap study was performed to determine the number of opportunities a pedestrian has to cross Florinda Street in the morning and afternoon vehicle peak hours. Based on calculations, a pedestrian will take 15 seconds to cross Florinda Street. The gap study shows that there are 4.5 opportunities in a 5 minute period during the peak vehicle hours for a pedestrian to safely cross the road.

Based on the crosswalk study not meeting the basic warrants, Staff recommends that no additional intersection controls be placed at this time. Attached is an aerial photo of the area, warrant for pedestrian crosswalks, and the entering volume summary.

LOCATION: FLORINDA ST. AT SEQUOIA CIR.WARRANTS FOR PEDESTRIAN CROSSWALKS

In order to qualify for a marked crosswalk, a location must: (A) meet the following basic warrants, and (B) rate 16 points or more under the following point system:

Are there more than 20 pedestrians crossing during peak hour?

Crosswalks will not be installed where the pedestrian volume is less than 20 pedestrians per hour (pph) during the peak pedestrian hour.

☒ ☐Approach Speed Warrant**Is the 85 percentile less than 45 mph?**

Crosswalks will not be installed on roadways where the 85th percentile approach speeds are in excess of 45 mph. The approach speeds shall be determined by approved engineering speed study techniques. All crosswalks installed on roadways in excess of 40 mph will require additional safety improvements (ie. traffic-calming treatments, flashing beacons, and/or rapid flashings signs, etc.)

☒ ☐Visibility Warrant**Is visibility clear for 200'?**

Crosswalks will not be installed unless the motorist has an unrestricted view of all pedestrians at the proposed crosswalk site, for a distance not less than 200' approaching from each direction. Sites with grades, curves and other sight-restrictive features will require special attention.

☐ ☒Illumination Warrant

Proposed crosswalk site must have adequate crosswalk lighting in existence or scheduled for installation prior to the installation of the crosswalk.

Crosswalk on Centennial Drive at the Softball Complex

RECOMMENDATION:

That a crosswalk not be placed on Centennial Drive at Softball Complex.

BACKGROUND:

Staff received a request from Commissioner asking if a crosswalk could be placed on Centennial Drive at the Softball Complex. It was stated that students are crossing in this area. To address this concern, staff conducted an intersection study of the location.

Centennial Drive is a north-south bound two-lane arterial street with a curb to curb width of 63 feet. This width is adequate for a single lane in each direction with room for street parking on both sides.

The speed limit on Centennial Drive is 45 MPH and the 85th percentile speed is 47 MPH. In the last five years, there have been 0 accidents reported. The sight stopping distance at the intersection is adequate for north and south bound traffic. There are no schools in this area. The nearest school, Sierra Pacific High School, is located on 13th Avenue.

A gap study was performed to determine the number of opportunities a pedestrian has to cross Centennial Drive in the morning and afternoon vehicle peak hours. Based on calculations, a pedestrian will take 16 seconds to cross Centennial Drive. The gap study shows that there are 6.0 opportunities in a 5 minute period during the peak vehicle hours for a pedestrian to safely cross the road.

Based on the crosswalk study this crosswalk location does not meet the basic warrants, Staff recommends that a crosswalk not be placed at this time. Attached is an aerial photo of the area,

warrant for pedestrian crosswalks, and the entering volume summary.

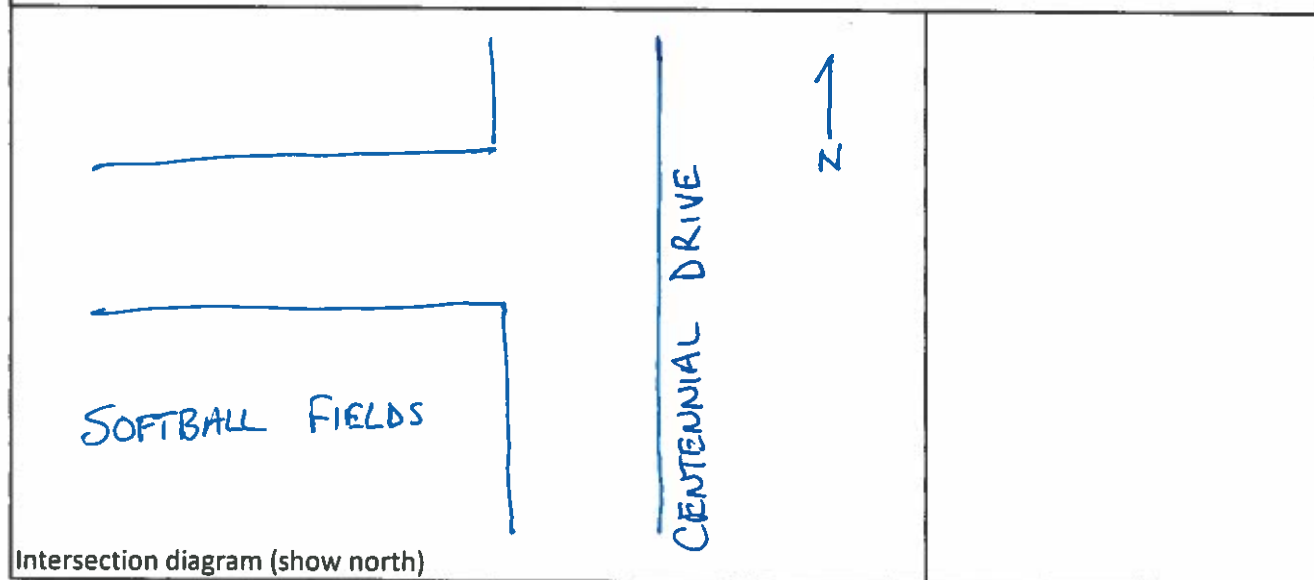

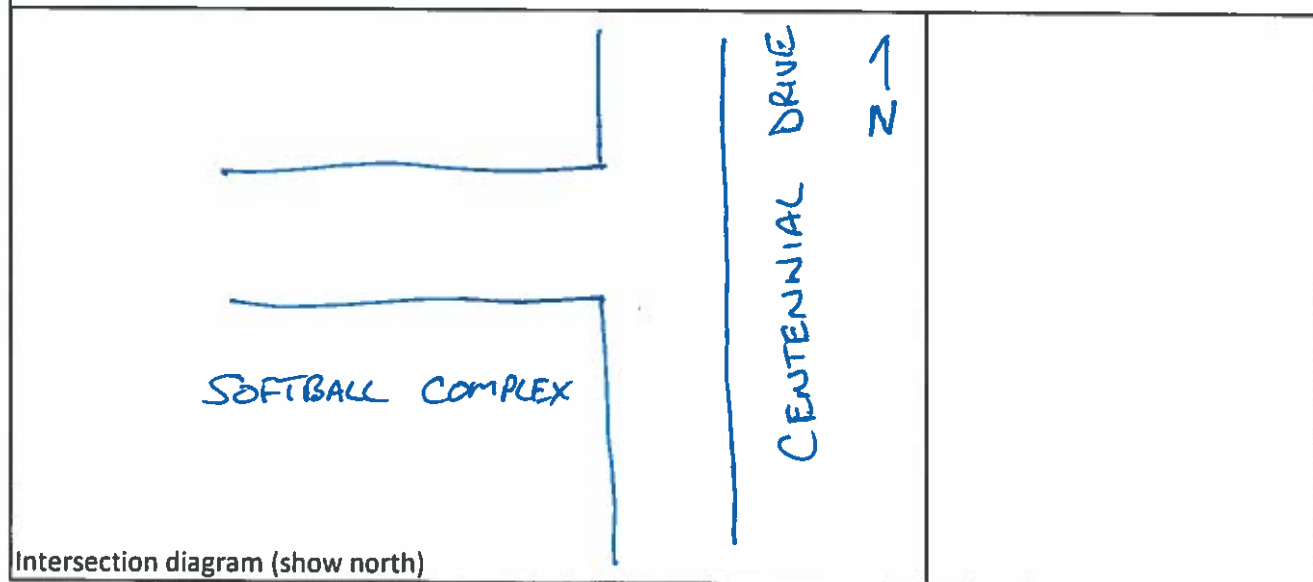

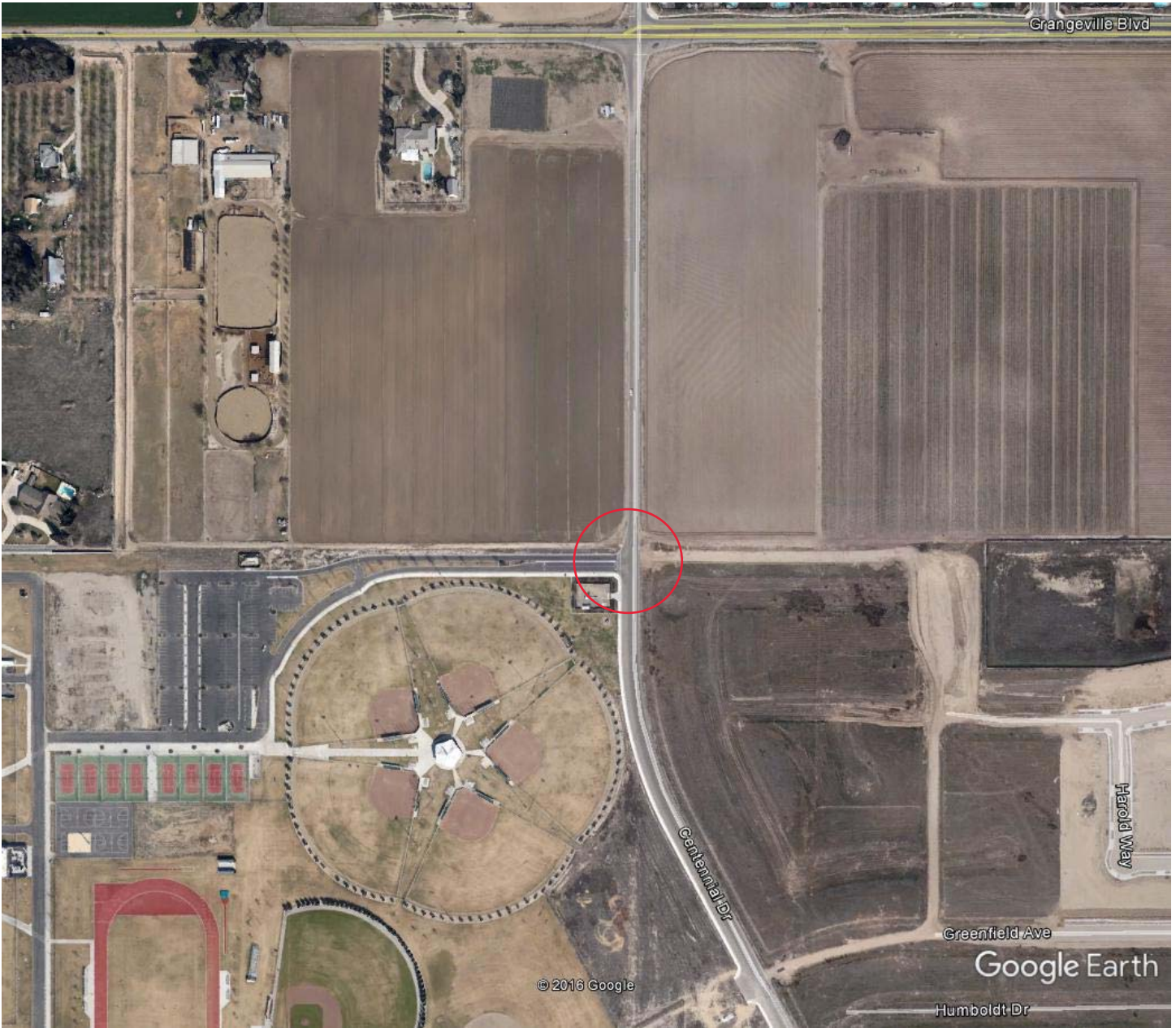

Flashing Beacons on Harris Street Crossing at Saint Rose McCarthy School

RECOMMENDATION

That a Flashing Beacons not be placed at the crosswalk on Harris Street at Saint Rose McCarthy School.

DISCUSSION

Staff received a request from Ronnie Wrest asking if flashing beacons could be placed at the crosswalk located on Harris Street at Saint Rose McCarthy School. Mr. Wrest stated that students are crossing at various times of the day all day. To address this concern, staff conducted an intersection study of the location.

Harris Street is a north-south bound two-lane residential street with a curb to curb width of 36 feet. This width is adequate for a single lane in each direction with room for street parking. The speed limit on Harris Street is prima facie 25 MPH. The 85th percentile speed on Harris Street is 28 MPH. The sight stopping distance at the crossing is adequate for north and south bound traffic.

This crosswalk is unique in that the school uses adult crossing guards as well as teachers to cross their students. The crossing guards and teachers check traffic before continuing and then the students cross in groups of 15 to 25 at a time. The crossings do occur at various times all day.

The warrant for a flashing beacon was checked, and the crosswalk does not meet the warrant based on low vehicle volume, Staff recommends that Flashing beacons not be placed at this time.

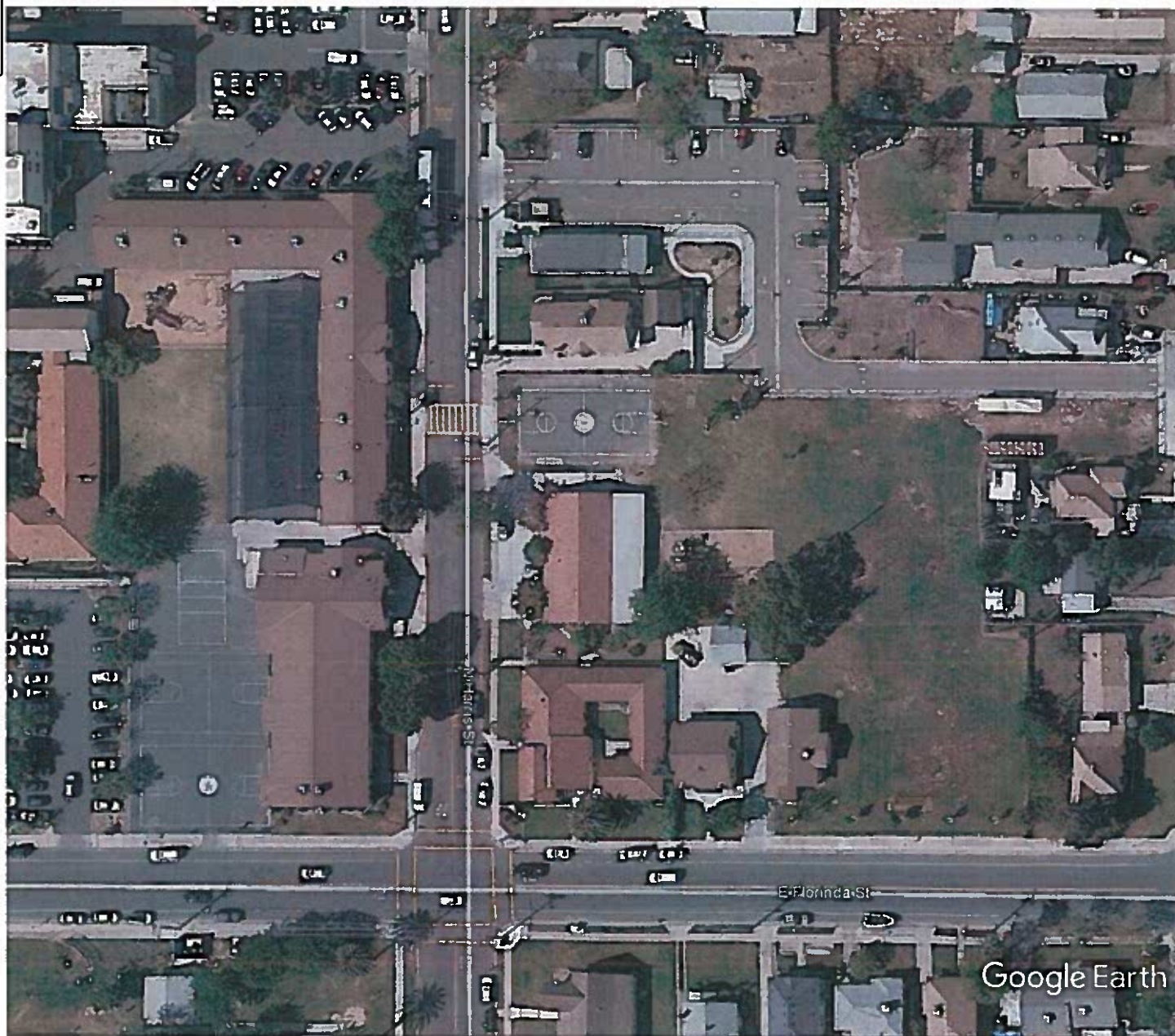

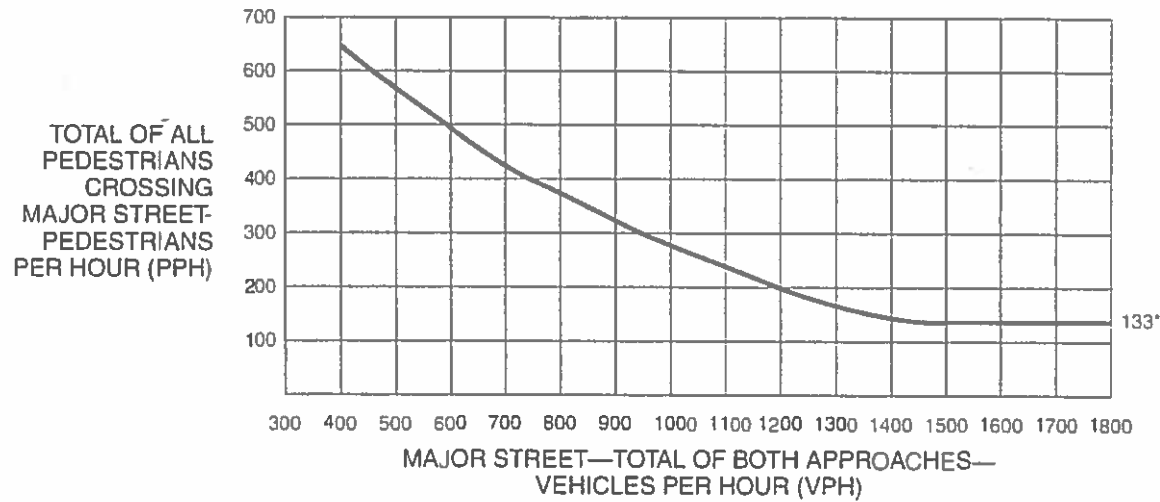

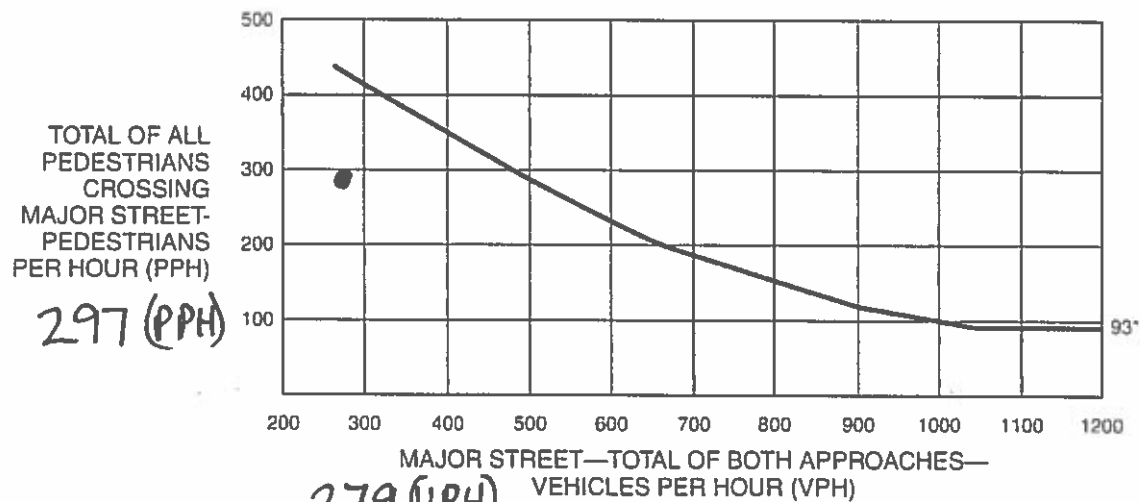
Figure 4C-7. Warrant 4, Pedestrian Peak Hour
